NOW THIS DEED OF TRUST. WITH WITNESSES AS UNDER:-

1. The Trust will be known as "KERALA PUBLIC SCHOOL TRUST"
2. The objects of the trust are:
  - i) to open, run, continue educational and vocational School or institution in healthy and salubrious surroundings
  - ii) to engage teachers, professors, instructors and experts of good moral character and conductable to impart efficiently at economically upto date. instruction to pupils, & students in Modern Sciences, industrial avocations, Research work, intellectual and other useful pursuits
  - iii) to develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and all those connected with the institution so as to make them good citizens.
  - iv) to establish, maintain, and run a boarding house and residential institution for the students and those connected with the institution

4. THE BOARD OF TRUSTEES WILL EXERCISE THE FOLLOWING POWER, DUTIES AND RIGHTS: —

(d) to borrow on the security of the property of the trust, money, fixed deposits, current accounts etc, for the purpose of the Trust  
(e) to raise money, income or receipts into the corpus of the trust and to take out spend and or use the same as and when deemed necessary  
(f) to appoint, dismiss, discharge, suspend teachers, its trust, committee or sub-committee or employees  
(g) to open, close and maintain account as per law

 6. MEETINGS OF THE BOARD OF TRUSTEES.

- a) The Board of Trustees shall meet for the transaction of business at such time or place as may be notified.
- b) The Chairman or in his absence, any trustee chosen by the trustees from among themselves shall preside at a meeting of the Board of Trustees.
- c) All questions which may come before any meeting of the Board of Trustees shall be decided by majority of votes of the trustees present and in case of equal votes, the chairman of the meeting shall have a second or casting vote.
- d) The Board of Trustees shall meet at least four times in a year and the period in between the two meetings shall not be more than 90 days. —
- e) All the proceedings of the meetings shall be recorded in the minute books and shall be signed by the chairman of the meeting in the succeeding meeting.
- f) To make quorum of the meeting 50% of trustees attendance will be necessary however for adjourned meetings presence of three trustees will be sufficient.

- b) The chairman or any trustee of the board may be removed by 2/3rd majority of the trustees.


