P.S. Manjo, in the town of Jashodpur under the control and supervision of Board of Directors under the chairmanship of Mr. A.P.R. Nair, P/3



NOW THIS DEED OF TRUST, WITNESSETH AS UNDER:-

1. The Trust will be known as "KERALA PUBLIC SCHOOL TRUST"
  2. The objects of the Trust are:
    - i) to open, run, continue educational and vocational school or institutions in healthy and salubrious surroundings
    - ii) to engage teachers, professors, instructors and expert of good moral character and conductable to impart efficiently and economically upto date instructions to pupils at students in modern sciences, industrial avocations, research work, intellectual and other useful pursuits
    - iii) to develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and all those connected with the institution so as to make them good citizens.
    - iv) to establish, maintain and run a boarding house and residential institution for the students and those connected with the institution

- 5) to invest, dispose of transfer and otherwise deal with the subject matter of the trust in such manner as the trustees should deem fit so as to enable the society to carry on the objects of the trust effectively

- vi) to accept donations, grants, presents and other offerings and to deal with the same for the purpose of the Trust
- vii) to charge moderate tuition fees and otherwise recover them selves for the out lay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this deed.
- viii) to train and equip the pupils so as to be self supporting, in an honourable and decent way of life so as to develop into good, healthy, and progressive citizens
- ix) to promote and inculcate the dignity of labour, the appreciation of intellectual gifts, and talents of all kinds
- x) to encourage sports and adventurous spirit in the pupils and those connected with the institution and coming in contact with them and to participate in games of skill and prowess
- xi) to develop disciplinary conduct and a habit

- to observe the rule of law and self restraint
- xii) to bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford opportunity for research work in art, science and industrial undertaking.

### 3. APPOINTMENTS OF TRUSTEES IN CASE OF VACANCY.

- i) any person irrespective of caste, creed religion or sex shall be eligible to be appointed as trustee by the Board of Trustees provided -
- (a) he is not less than 21 years of age.
- (b) he is not unsound of mind.

- (c) he is not an undischarged insolvent  
 (d) he is not a convict of an offence of moral turpitude

(e) A Trustee shall continue till his life time unless he tenders Resignation or leaves India for good.

4. THE BOARD OF TRUSTEES WILL EXERCISE THE FOLLOWING POWER, DUTIES AND RIGHTS:

- (a) to provide for education and instructions in such branches of learning as may be deemed desirable and be found practical and for promotion of understanding of culture modern and ancient and for advancement of P.T.B. (3<sup>rd</sup> A.P.R. No. 15.12.98 Ed. - K.H.H. Kotha s.d. Manorama No. 15.12.98 s.d. V. Kotha) - 6 learning and dissemination of knowledge generally
- (b) to set up production cum training centres for the education and/or advancement of knowledge of the students in various fields of vocation and profession
- (c) to deal with any property belonging to or vested in the trust in such manner as the trust may deem fit and proper
- (d) to borrow on the security of the property of the trust, money, fixed deposits, current accounts etc. for the purpose of the Trust
- (e) to raise money, income or receipts into the Corpus of the trust and to take out spend and/or use the same as and when deemed necessary
- (f) to appoint, dismiss, discharge, suspend teachers, professors, instructors and staff or employees of the trust, Committee or sub-committees
- (g) to open, close and maintain account in any bank, in the name of the trust, Committee or

Sub Committee or the Care may be as to be decided by the Board of Trustees from time to time. —

(h) to form, amend, approve and implement the pay scales and terms and conditions of employment of P.T (Sd. A.P.R. Nair 15/11/98 Sd. K.H.H. Kertis Sd. Manorama Nair Sd. V. Kertis) —

all employees working for wages and salaries of all descriptions and designations employed by the Trust, its Committees, Sub-Committees and to take, suitable actions as per law in case of violation of the said terms and conditions of the employment

(i) to do all things as the Board of Trustees may decide necessary in the interest of promotion of the Trust,

5. MANAGEMENT OF THE TRUST:

(a) The minimum number of the Trustees shall not be less than THREE and the maximum shall not be more than seven at any given time.

(b) The office of the Trust shall be at 7/2 Sarpa, Gangotri Complex, Kaduna Junction, 831005 —

(c) All the trustees will constitute the Board of Trustees.

(d) There shall be a Chairman of the Board of Trustees who will be elected by the Trustees of the Board among themselves

(e) The Chairman of the Trust may nominate any member of the Trust Board as the Managing Trustee cum Treasurer to carry out day to day affairs of the Trust

(f) The Trustees shall be entitled for reimbursement of any expenses reasonably

6. MEETINGS OF THE BOARD OF TRUST.

- a) The Board of Trustees shall meet for the trans-  
action of business at such time or place as may  
be notified
- b) The Chairman or in his absence, any trustee,  
chosen by the trustees from among themselves  
shall preside at a meeting of the Board of  
Trustees
- c) All questions which may come before any  
meeting of the Board of Trustees shall be decided  
by majority of votes of the trustees present and  
in case of equal votes the chairman of the  
meeting shall have a second or casting vote.
- d) The Board of Trustees shall meet at least four  
times in a year and the period in between the  
two meetings shall not be more than 90 days.
- e) All the proceedings of the meetings shall be  
recorded in the minute books and shall be  
signed by the chairman of the meeting in the succee-  
ding meeting.

f) To make quorum of the meeting 50% of Trustees  
attendance will be necessary however for adjourned  
meetings presence of three trustees will be sufficient
